NZSI Constitution Correction (see 8 above)

Dear NZSI Members,

As required we are circulating the following correction of the NZSI Constitution for a vote at the upcoming AGM. The bold wording is to be replaced by the wording in RED.

14(c) The Committee of the Branch shall consist of a Chairperson, vice-Chairperson, Secretary and Treasurer and at least one other member, all of whom shall be elected by the Current Financial Members of the Branch at each Branch's Annual General Meeting to be conducted in accordance with clauses 16(a), 16(b) and 16(c) 14(e)(i), 14(e)(ii) and 14(e)(iii) of these rules. It is recommended that such committees consist of at least, one-third Institute registered teachers and one-third parents of children being taught under The Suzuki Method.

14(d) Any Branch formed pursuant to this clause shall be bound by the rules and policy of the Institute and shall conduct its affairs in accordance with the Institute's objects. A Branch may formulate its own financial policies PROVIDED THAT any

actions taken under clauses 3(b) and 3(c) shall require the prior written approval of the Executive.

- 14(e) The Branch Annual General Meeting shall be held prior to the Institute's Annual General Meeting on a date approved by the Institute's Executive, for the following purposes:
- (i) To receive the Chairman's report, the Treasurers balance sheet and statement of accounts for the preceding year;
- (ii) To elect the Officers and Members to the Branch committee for the ensuing year;
- (iii) To transact any other business in general.
